GENERAL INSTRUCTIONS

- The nomination of candidates to the election shall be made in the prescribed format, which is enclosed herewith. Every nomination together with the written consent of the candidate to contest the election duly proposed by one and seconded by another Active ISA Life Member shall be sent to the Honorary

Secretary, ISA Karnataka so as to reach him not later than 5:00 PM on 30-06-2026.

- Nomination/Application (signed copy) for these posts to be received from 15-06-2026 and must reach the Office of the Honorary Secretary, Indian Society of Anaesthesiologists (State) before 5:00 PM on 30-06-2026, by Registered Post with ACK due / Speed Post / Courier / E-mail /By hand at the Office of ISA State.
- A scanned copy of the nomination form should be submitted online / by E Mail also to isakarnataka@gmail.com
- The Immediate Past President will serve as the Electoral Officer and conduct Elections, if necessary.
- One person can file nomination for ONE POST ONLY.
- One person can send nomination for SAME POST ONLY TWICE on two separate occasions.
- Contestant shall not be holding any post in the executive committee board of National / State / City while submitting nomination. (As per special AGBM of ISA National held on June 7th 2025).
- If in case any contestant holds a post in the executive committee board of National / State / City, he / she should have resigned for the post through proper channel before the date of elections notification. (As per special AGBM of ISA National held on June 7th 2025).
- If any contestant resigns from any post on the executive committee board of National / State / City, he / she shall not be eligible to contest till his / her actual tenure of the held post is over.
For example, an executive committee member with tenure till October 15th 2025, resigns any time before October 15th 2025 he / she shall not be eligible to contest till October 15th 2025 (as per special AGBM of ISA National held on June 7th 2025).
- Any contestant having occupied higher post cannot contest for lower post.
For example vice president can apply for only president post. Likewise secretary can apply for vice president and president, treasurer can apply for secretary, vice president and president, Editor can apply for secretary, treasurer, vice president and president and EC members can apply for any above post.
- **Vacant posts, if any after the elections, shall be filled up from the ISA members of the state present in the immediate next regular AGBM at the state conference.**

ELECTION DEPOSIT / NOMINATION FEE :

- Each nomination must be accompanied by self-attested proof of the nomination fee.
- The Nomination fee is **REFUNDABLE ONLY FOR THE ELECTIONS FOR THE YEAR 2026 SUBJECTED TO RATIFICATION IN THE AGBM - 2026 AND IF NO ELECTION IS REQUIRED FOR ANY POST.**
- The Nomination fee should be in the form of NEFT / cash deposit in favour of "Indian Society of Anaesthesiologists Karnataka State Branch" payable at SBI, Tipusultan Palace Road, Branch, Chamarajapet, Bangalore (SBA/c No.64026776839, IFS Code SBIN0070242).

Eligibility criteria:

President Elect and Vice-President

1. Contestant must be a continuous member of society for not less than ten years.
2. Must have at least 1 complete term prior experience in the executive committee of state ISA.
3. Should have attended and signed the register on at least 3/5 Regular AGBM attendance in immediate prior ISA Karnataka state conferences.
4. All candidates below the age of 60 years should mention their FBF number in the nomination form which is mandatory requirement also per ISA National Guidelines.

Executive Committee Member

1. Contestant must be a continuous member of society for not less than five years.
2. Should have attended and signed the register on at least 3/5 Regular AGBM attendance in immediate prior ISA Karnataka state conferences.
3. Desirable to have prior experience the executive committee of the city branch of the Karnataka state.

4. All candidates below the age of 60 years should mention their FBF number in the nomination form which is mandatory requirement also per ISA National Guidelines.

Highest standards of our Specialty and Maintenance of integrity of ISA are expected during this election period.





ISA Karnataka State Branch Elections 2026

GENERAL GUIDELINES FOR CANDIDATES AND VOTERS

- Canvassing by personal contact, SMS, E-Mail, Telephone calls is allowed.
- No paid bulk SMS and recorded (audio & video) phone messages are allowed (including Greetings).
- Canvassing in social media is allowed.
- Only candidates are allowed to campaign in the social media. No group forward is allowed by any ISA Member.
- No candidate should attend any ISA related event as a faculty from 15th June 2026 till 20th July 2026. However, they can attend these events as ordinary delegates.
- Use of ISA logo and ISA Flag is strictly prohibited in flyers.
- The candidates should do positive campaign and maintain the dignity of our profession and sovereignty of our constitution.
- No negative campaigning is allowed. Any negative campaigning will invite penal action from ISA Karnataka State Branch which will vary from simple warning to suspension of the candidature depending upon the degree of offence. If proved to be true, the penal action taken will be final.
- Use of derogatory remarks, language or comments against other candidates is strictly prohibited.
- Nobody (candidates/ members) is authorized to send messages in name of ISA, Karnataka State Branch. This is cyber-crime and impersonation. If any member sends such sms, he/she will be suspended from ISA Membership.
- If a non-member sends, suitable action will be taken against him/her after reporting to cyber-crime cell.
- The campaigning should stop on 15th July 2026 by 8 AM. After that only personal calls / sms are allowed.
- The sitting State Office bearers should not use official letterhead for campaigning.
- The ISA state Office Bearers/ Executive Committee Members cannot occupy positions in the city branches. If any candidate is occupying higher post, that person cannot occupy lower post. If this is done, then that person cannot apply for 10 years for any higher post. No person can occupy two posts in any ISA Formation simultaneously whether in National, State or City executive body. In the oath form to be filled by incoming Office Bearers / Members of the ISA Karnataka State Branch, it shall be mentioned that he/she solemnly swears and affirm that I am not holding any post in ISA City Branch.


