Hon Secretary Dr Henjarappa requested the AGBM to inform ISA Karnataka State Chapter about the demise of city branch ISA members through City secretary.


2. Confirmation of minutes of meeting of AGBM

He also requested to consider our request of conducting the same in 2027 March at Bidar institute of medical sciences.


